Work logs for trail takedown to be submitted to Rich M. Trial between lapp & Marvin's needs new trail captain. Town of Clarence, ditching between Sesh & Wolcott Rd., will need culverts installed at trail crossings, Town to be contacted for further information. Bridge by Crosby Rd. will need a overhaul & re-deck, Curt W. will give further details. Concern about where to store barrels, current storage location may no longer be available. Al W. reported the need to put in a culvert in a nasty ditch on the gas line, South of Howe Rd., before the bike path. Ron D. will look into what we need there.
