January 17, 2011 - The New York State Snowmobile Association is pleased to announce the selection of Dominic Jacangelo as its new Executive Director.

Gary Broderick, NYSSA President, said "As we position NYSSA to meet future challenges and protect Snowmobiling in New York State from government sweeps and arbitrary decisions that affect snowmobiling negatively, I would like to announce that Dominic Jacangelo has been named Executive Director.

As a former Deputy Commissioner of OPRHP, Heritage Trails Manager, and former Director, New York State Senate Standing Committee on Environmental Conservation, Dominic brings a wealth of experience to the position of Executive Director. His vast knowledge of the inner workings of OPRHP and state government will be an invaluable resource to NYSSA and its clubs.

Dominic has an extensive background in state law and procedures along with a network of contacts throughout state government. We at NYSSA feel that Dominic is the right person to lead us through an ever more challenging period for organized snowmobiling in New York State. I look forward to working with Dominic and advancing our clubs' agenda."

Dave Perkins, who has been covering the Executive Director duties since Jim Jennings' retirement in May, said "I've known and worked with Dom for many years. Board Meeting February 15, 2011 Summary
Marvin's Restaurant Clarence Center, NY 7:00 PM

Officers present:

President – Eric Glassman
Vice President – Dan Dressel
Secretary – Mary Beth Kiesel

Meeting called to order at 7:09 PM – 12 people present
Meeting ended at 9:45 PM



Review actions from last meeting:

- 1) Budget. Do we need to purchase anything else for this year?

Trails:

- 1) Curt W. may need a bridge next year. We need to locate shovels, wrenches and chairs for our groomer. We have tools, where are they? Bill P. may have some. We are missing cutters also. Gloves, flairs, flashlights, bolt cutters should all be on the groomer. Eric G. will ask Rich W. about these items.
- 2) Ship & Shore. Did the bridge get it? No. There is an old bridge that we repaired. We could chain bridge around large tree to prevent it from floating away. We can remove come spring. It's a summer job.
- 3) Landowner is having sleds run through his runway. We will talk with landowner and may add signs to help him. Randy W. will speak with him. The runway at Transit Road may also need signs.
- 4) Trail heads/ID signs. There is a trailhead sign down on bike path. We will fix at end of season. We need GPS signs up - are they all up? Eric G. will check with Steve W. to locate our 6 "Welcome to NESS Trails" signs.
- 5) Dale Dunkeburger trail. He wants to move the bridge to the east side. Maybe we can mark a water level so we know how deep the water is.
- 6) Wolcottsville Inn. There is traffic to his restaurant. Owner seems happy.

Marketing/Membership Items:

- 1) Newsletter/website. We need to update the information for sponsors and advertisers.
- 2) Safety Course. We had 36 students. Mary Beth sent a Thank you note to Swormville Fire Hall for use of their wonderful facility. Randy W. mentioned that one of the students donated \$20 to our club for our "Great Safety course"!
- 3) Enjoy the City books. We had a few books donated back to our club, so we will be raffling them off at our next general meeting to our landowners. We can't thank them enough - without them - we would not have our wonderful trail system!
- 4) Bon fire. We had our annual bon fire on February 5th. It was really snowing hard all afternoon. We want to thank The Zimmerman Family for use of their property and for their horses that were ready to give rides! We all had a wonderful afternoon from roasting marshmallows to eating chili and hot dogs. The hot cider was a nice touch! Check out our pictures on our website - if you can see through the snow!

Groomer/Maintenance:

- 1) UTV trailer. Curt W. has trailer. Eric G. would like it so he can add tie downs and a few other things.
- 2) Fuel. We should have enough for the rest of the year. Bill P. says we should be good for Erie County.
- 3) Groomer policy. We currently have 270 hr on the Piston Bully and 77 hrs. on the Bombi. Last year we had a little over 200 com-bines. How old do the groomer rookie riders need to be before they go out on their own? 18 years old. It says in the groomer policy. The seasoned operators than decide for themselves when the rookie operator is able to do it themselves. Bill P. says that when the conditions are good - grooming is easy, it's when the conditions are tough - grooming is a chore. Let's keep the age to over 18 year old until we decide as a club to review that policy in our By Laws.



Other:

- 1) Elections. We have a few positions that will be open this year.
 - A. All four officer positions are held for 1 year. Eric G., Dan D., Mary Beth K. and Rich M.
 - B. We have 3 board member positions open. It is held for 2 yrs. Curt W., Frank S. & Randy W.
 - C. Sergeant of Arms position is held for 1 year. Rich W.
 - D. Trail Coordinator. Steve W.

What do the By-Laws say about having 2 ballots? Family Memberships have 2 ballots.
- 2) Bike path accident. Eric met with our NYSSA insurance investigator, just in case there is a problem. They collected information and no further action is required at this time. We do have the dispatch and police report on file.
- 3) Town of Royalton. We may need to move the road crossing over 5 ft. each year so as to not ruin the road when crossing the street with sleds
- 4) C4H accident. January 22. 3 sleds with 3 DUT's. Niagara County Sheriff should have a report. Eric will contact the Sheriff to get the details. Curt W. will get Eric G. the phone number.
- 5) Clarence Pizza. Tim from Pizza Inn wants to have a sled party. Our trails may not be open to have a sled-in. We will probably not have any snow with the anticipated warm up. Eric said a sled-in, car-in and groom a runway for a plane to land. Bottom line - our trails will probably be closed anyway. Bill P. asked what is the club and board member's insurance liability in an event like this. We need to review the insurance policy before another decision is made that affects the officers and board members' liability in an activity like this.

Rich W. motions - Any outside use, non-existing trail work, of groomer needs to go before the board and any groomer use off our trail system. Randy W. 2nds. 11 in favor. 0 opposed. It's carried.
- 6) Police reports. If there is an accident, who do we call? We need to publish a list of phone numbers so we can call in "real time".
- 7) Public Relations. We need to think about ways to promote our club. Mary Beth suggests we put a picture of our Safety Course in the Bee. She thinks that would be positive PR for our club.
- 8) Priorities for year.
 - A. By laws - we have final copy - will vote in spring.
 - B. Club ride and functions. We did pretty well with this.
 - C. Committees. Dan has a good handle on this.
 - D. 2nd UTV and trailer. We need a trailer for the first UTV.
 - E. Reward system for volunteers. Still needs to be discussed.
- 9) Pay bills. Curt W. requests a little more detail on our Treasury report - list name, amount and purpose of check. Frank S. mentions that according to Robert's Rules, the board is supposed to decide what gets paid - not what was paid. Let's just spell it out on the Treasury report for now.
- 10) Newsletter. She will set up due dates for articles for the newsletters and have available for next meeting.
- 11) Feedback. Scott T. received 3 phone calls about the safety course: Wonderful food, facility and instructors. He also was told that the bon fire was the best yet! Maybe we should start the bon fire a little earlier next year. The port a potty was a good addition.
- 12) Akron trail. Maybe we should put a sign up that states "we don't groom so slow down" near the Akron bridge trail - so riders will be aware on why it is bumpy.
- 13) Canal bank. The state has opened the way for clubs to get landowner permission for new trails and then the required per mission for the towns involved. This will take time.

Our next General meeting is February 24th at 7:30 pm at Tillman post in Akron.

Our next Board meeting is March 10th at 7:00 pm at Marvin's Restaurant in Clarence Center.

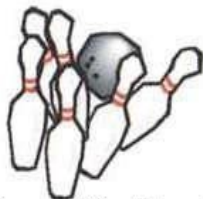

Meeting ended at 9:45 PM

Welcome:

Welcome to all. Thanks for coming! As of tonight we have 757 members! We count just applications. We probably have over 1000 with families! That's more than last year. People are still joining!

Business Items:

- 1) Approval of minutes from last meeting. Dave F. makes a motion to approve minutes from last meeting. Randy B. seconds it. 24 in favor - 0 opposed. It's carried.
- 2) Order of Business: 1 - We have Gary Broderick here tonight. He is the president of NYSSA.
He will be speaking later this evening. Welcome Gary!
2 - Trail discussion
3 - Nominations
- 3) We have had a number of fun events this year. We participated in the Clarence Winter fest, Buck's dice run and our annual bonfire. Thank you to everyone who helped make these events a success!!
- 4) Bon fire. We had over 100 sleds this year. The snow was really coming down!! Thank you to the social committee for putting it all together. We would also like to thank the landowner. We really appreciated you letting us have our bonfire on your property this year. Thanks for bringing your horses and sleigh. It was a great addition to our bon fire. We look forward to another one next year!
- 5) We are looking for a newsletter editor. Mary Beth is temporarily the editor. Let us know if you would like to help! March Newsletter will be the last one mailed for this season. April, May, June, July will be on our website: www.snoseekers.com.
- 6) By Laws. We have amended the by laws to more of what the club is doing. We will publish it shortly and mail to our members to vote. So, please keep an eye on your mail. We need membership approval for the changes to happen! Thanks.
- 7) Committees. Dan D. has organized a committee list. Each committee has been defined now. We will be having committee updates at our meetings. We look forward to these changes. Please, committee chairpersons, turn in your completed lists at our next board meeting. Thanks.
- 8) Annual Forum. We will need to plan for the trip this year in Liverpool. More details to follow. There will be a discussion about the trail grant fund being removed from the states' control. There will be a class on chain saws and also a groomer course. Ness donated a welder to Forum this year. The forum has a number of awards they hand out. From "groomer", "family", "snowmobiler" to "dealer" of the year and more. We can fill out an application. If one wins, their name may be printed in the American Council for Nyssa magazine. The application needs to be turned in by March 18th.

Trail System:

- 1) We have 77 hrs on our Bombi in Niagara County and 249 hrs on our Piston Bully of grooming this year - so far... That's 326 hrs total. We groomed 19 days with the Bombi and 29 days with the Piston bully. That is 39 shifts over 29 days. Our first day was December 10th and the last day we groomed was February 14th. We haven't calculated the gallons of fuel yet.
- 2) Work logs. Please have your work logs completed. We need to record the amount of time worked, name of workers and tools used. We will need to submit these to Rich M. They are due for Erie County on April 5th. All work done as of March 31st should be documented. So please, get Rich M. your logs.
- 3) Trail closed. The trail in the Village of Akron next to the power station will not exist next year between Bloomingdale and Akron Roads. 3 sleds drag raced into the owner's fence and broke it. Not only that, his Belgium horses got loose and no one told the owner. This is why we say - "stay on trail or go home". It only takes 1 sled to ruin it for all of us. This was an important part of our trail system and now we don't have it. Dan D. has spoken with the owners and will be the contact with the landowners. We appreciate them and we thank them for letting us use their property this year. It is a fun trail and will be missed by all. NESS will pay for any damage to the fence.



Curt mentioned that we need to make the bridge at the trailer park better. Beattie Road and Transit. The truck deck needs re-decking. If anyone sees an issue, please let us know so we can fix it.

President of NYSSA:

- 1) Gary Broderick spoke about the removal of \$1,000,000 from our trail fund. We kind a got it back in the last 4 years. Nyssa is writing legislation to remove our fund from the state budget. We will be privatizing the fund so the money goes where it is intended to go. The state of Vermont already does it this way and it works for them.
- 2) Canal Corp proposal. NYS has opened the door for local clubs to request approval for trails.
- 3) Public relations. Snowmobile clubs in general don't get good press. The Sno-chiefs had a rescue practice with their fire department. They submitted it to the press and no one printed it. He mentioned that we need to highlight the positive events we participate in. The work we have done with the Thruway Authority is good.
- 4) There was a discussion about getting a sticker for your sled each year that confirms the sled is registered and insured. Children under 17 will also show they took the safety course. There has been law enforcement on our trail system this year. It's been good. If you have your information handy, when you get stopped - it shouldn't take too long.

For the Good of the Club:

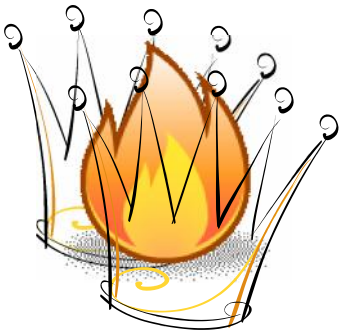
- 1) We had a 50/50. Congrats to a customer at the bar. He won \$78.00.
