

The Phantom chooses to ignore the fact that he has not been out once this season on his sled. Instead he chooses to talk about trail etiquette. We all see snowmobiles with poor trail-side manners. This is quite possibly because we don't talk enough about them. What is acceptable and what is not.... in no particular order:

- 1) Crossing private property. This is a privilege, not your right. While the phantom maintains a stock exhaust system, he still attempts to slow down and keep his sled's noise to a minimum while passing peoples' houses. Why get them mad. Loud exhaust systems are out! They are not cool anymore. They are kids stuff. They are unnecessary also. There are plenty 175 horsepower sled out there that are quiet. Stealth is in...
- 2) What about waving to the property owner whose land you are crossing? This simple friendly act goes a long way in keeping trails open.
- 3) Stopping on the trail. Pull off the trail as far as you can safely, go and park in single file-not spread across the trail. Safety dictates you stop on a straight section of the trail so people can see you have stopped and hopefully they will slow down. Don't stop just before or after a curve or hill top.
- 4) Signal to on coming traffic that there are other people in your group behind you. Two schools of thought on this topic. Some say you should signal with fingers how many sleds are behind you or at least signal with a thumb that others are following if wearing mittens. Others say that your hand should never leave the handle bars thus lessening the chance you could lose control of your machine. There are those yellow and green handle bar mounted lights that the group leader and the last sledder in line would use-a nice idea if more people had them. The Phantom prefers hand signals. He like the idea of those warning lights but find them a little pricy-although cheap compared to a hospital stay-maybe a good gift idea for the Mrs. next Christmas present....The Phantom can go on and on about trail etiquette, but the moral of the story is a little patience, decency and common sense will improve your snowmobile experience and the image of snowmobilers in general.

#### 7) Groomer/UTV Equipment.

- A. Groomer class. There is one scheduled in Eden on January 15<sup>th</sup>. Steve is going so far, does anyone else want to go?
- B. Groomer Policy. If there are any issues on the trail we should try to solve them immediately. If it can't be solved, then the trail captain should be contacted with the issue. All work should be documented in the groomer log.
- C. Ranger. The Ranger is at Dale's getting the CV joint fixed. It should be ready in a few days.

#### 8) Trail/Landowner.

- A. Terry's Corner. Bridge work was finished. Re grade work still needs to be done.
- B. Trail heads are up.

- 7. <u>Membership Committee:</u> Responsibilities include receiving applications and processing memberships. Producing vouchers for sled registrations and decals with the temporary NESS membership cards. Responsibilities would also include distributing applications to various locations around town.
- **8.** <u>Groomer/UTV Equipment Committee:</u> Responsibilities include keeping the groomers and drags in working order, organizing the grooming schedules for the winter and organizing groomer education/safety courses. Keeping UTV in working order and organizing UTV usage for trail work.

All trail openings and closings are determined by this committee. Erie County Niagara County

- 11. <u>Newsletter Committee:</u> Responsibilities would include creating each month and coordinate input from others and have ready to print our newsletter for either print or website.
- **12.** Website Committee: Responsibilities would include moderating and update with activities and club news. Keeping the website functional and register users for site.



#### 5) Social.

- A. We would like the trail captains to know that we will update our landowner list at our February board meeting.

- 6) Membership. We have 572 memberships as of today! We had 761 members last year at this time. NYSSA sent out an email to everyone that was a member last year and hasn't signed up this year as of 1/11/12. NYSSA is trying to help anyway they can. Al asked if we have heard anything from NYSSA about the lower amount of money we may receive next year due to the lack of groomer hours. We can ask at the next Fed meeting.
- 7) Groomer/UTV Equipment. The Ranger is all set. It's been repaired.
- 8) Trail/Landowner.
  - A. We had a problem this year with people riding our trail system when our trails are closed. We try to inform our members through our sno-phone and website about our trail conditions. One of the members spoke up and asked if we could contact the people who write the safety course to let them know that the 3" rule doesn't imply automatic trail openings. The safety course book needs to state to "contact your club for information". People see 3" and assume trails are open so they don't even check the club's website or phone. We need to have them change that. Gus, who teaches the railroad section of our safety course, would like us to try to get that changed. We also made up a note that we can put on vehicles that are using our system when it is closed. We have them tonight if anyone would like some, so if they see a vehicle they can put the flyer on their windshield. We do what we can for our landowners. I will also post in the newsletter too.
  - B. We were informed by the Erie Fed that the County would like some information about Beeman Park. We are in the process of getting the information to the Erie Fed guys.
  - C. We moved a trail off of a landowner's property it was mistakenly put there. It was on Strickler Road. A landowner requested it. So it is all set.
- 9) <u>Trail Guides</u>. Mary Beth brought the box of maps... Who needs them? Please write down how many you are taking on the lid of the box.
- 10) <u>Newsletter</u>. Did everyone get their newsletter on time? We will be mailing the February one so we have a due date for inserts on Sat. Feb 4<sup>th</sup>.
